**Agreement of Cooperation  
between the Department of Law of the University of Bremen  
and the ISPE College, Prishtina (Kosovo)**

- WHEREAS the cultural and scientific exchange is indispensable to academic institutions to develop their educational and research activities, their promotion through cooperation agreements between institutions for higher education is of exceptional importance;

- WHEREAS, a mutual interest exist between the Department of Law of the University of Bremen and the ISPE College in Prishtina, Kosovo in continuing the established collaboration relations for realization of joint interests;

- WHEREAS the European Union is open for close cooperation with the Western Balkans region and especially with Kosovo, the need for educational programs which provide proper knowledge in the field of European Law and Policy is of particular importance in this part of Europe;

- HAVING in mind the practical experiences with the collaboration between the ISPE College and the Law Department of the Bremen University (including the Center for European Law and Politics (ZERP)), and in conformity with the applicable provisions of the two respective parties hereto agree for entering into the agreement as the following:

## **Article 1**

The Department of Law of the University of Bremen and the ISPE College have the intention to pursue the development of different cooperation programs in the field of European Law and Policy. To achieve this, the undersigned parties agree for:

- a. mutual exchange of teaching and research staff with intention of pursuing seminars, conferences, lectures, joint research projects and exchange of other experiences in the fields of common interests and so forth;
- b. dissemination and exchange of publications and information on the specific field of study and research included in this agreement and on any other subject of relevant interest for the parties to the agreement;
- c. mutual support in literature sources, giving access to respective students of both parties in their libraries.
- d. student exchange for periods of study and research, attending courses, participating in professional training and specialization programs and other educational activities;

## **Article 2**

## **Article 3**

There are no financial obligations for the contract partners as a result of this contract. However, both will seek to raise third-party (external) funds to finance the activities that arise as a result of this contract.

## **Article 4**

The present agreement is concluded for a period of four years. If the contract is not actively renewed, it expires automatically. It may be amended by the agreement of the parties.

**Article 5**

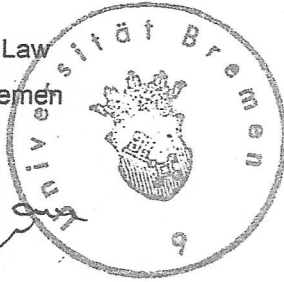
