**AGREEMENT OF COOPERATION BETWEEN THE REGENSBURG UNIVERSITY  
OF APPLIED SCIENCES  
AND THE ISPE COLLEGE, KOSOVO**

- WHEREAS the cultural and scientific exchange is indispensable to academic institutions to develop their educational and research activities, their promotion through cooperation agreements between institutions for higher education is of exceptional importance;

- WHEREAS, a mutual interest exist between the Regensburg University of Applied Sciences and the ISPE College in establishing collaboration relations for realization of joint interests;

- WHEREAS Europe is undergoing a process of continuing enlargement, and the Western Balkans region aspires to become a part of it in future, the need for educational programs which provide proper knowledge in the field of European Law and Policy is of particular importance in this part of Europe;

- HAVING examined the proposals for collaboration submitted by the Regensburg University of Applied Sciences and the ISPE College, and in conformity with the applicable provisions of the two respective parties, the parties hereto agree for entering into the agreement as the following:

Have agreed as follows:

## **Article 1**

The Regensburg University of Applied Sciences and the ISPE College have the intention to pursue the development of different cooperation programs in the field of European Law and Policy. To achieve this, the undersigned parties agree for:

- a. mutual exchange of teaching and research staff with intention of pursuing seminars, conferences, lectures, joint research projects and exchange of other experiences in the fields of common interests and so forth;
- b. dissemination and exchange of publications and information on the specific field of study and research included in this agreement and on any other subject of relevant interest for the parties to the agreement;
- c. mutual support and cooperation in reviewing existing curricula and the development of new ones in the future with the intention to remain current with educational development policies in both local and international level and to stay in trend with the needs of internal and regional market of labour and knowledge.
- d. mutual support in literature sources, giving access to respective students of both parties in their libraries, on-line libraries, and considering the development of joint on-line library.
- e. student exchange for periods of study and research, attending courses, participating in professional training and specialization programs and other educational activities;
- f. development and joint implementation of professional projects and providing expertise in the field of European law policy;
- g. exchange of experiences between the members of administrative and technical staff when considered that there are needed and profitable experiences from the parties to the agreement;
- h. enabling cooperation between students organizations of the participating universities.

## **Article 2**

Administrative bodies subscribing this agreement will exchange all relevant information by supplying catalogues and other materials to promote greater and mutual knowledge on their institutional structure and organization.

## **Article 3**

For purposes of implementing this agreement, the contact persons will be:

**Article 4**

The Regensburg University of Applied Sciences on the one side, and the ISPE College on the other side will define particular programs, forms and ways of participation in any specific event through separate acts and annexes to the original agreement of cooperation, and in accordance with their expressed needs and interests.

**Article 5**

The present agreement is concluded for an undetermined period of time. Each of the undersigned parties may terminate the agreement by giving the notice of termination at least six month ahead. The agreement's validity ceases with the expiry of the notifies termination deadline.

**Article 6**

This Agreement is compiled and signed in the English language. All copies are authentic. The present agreement will become effective from the date the contract is signed by the representative of the Regensburg University of Applied Sciences and the representative of the ISPE College.

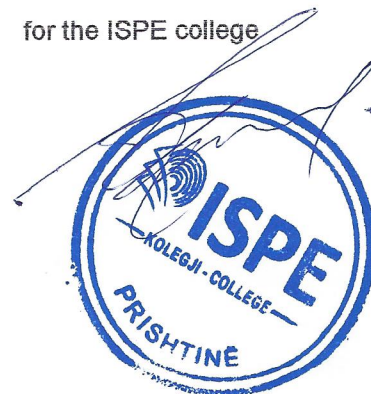
